2020 Oscar Medicare Advantage Certification

To sell our new Medicare Advantage plans, you must complete all six (6) required tasks listed below. Once you've completed all tasks in the checklist, you will be certified to quote and enroll your clients to Oscar's 2020 Medicare Advantage policies. Failing to complete the checklist prior to selling Oscar's Medicare Advantage policies will result in Oscar notifying CMS as well as cancellation of all commissions associated with those policies.

0/6 steps completed

- E-sign Medicare Advantage producer agreement
- Complete and transmit AHIP Medicare training
- Get appointed with Oscar in New York and/or Texas

STEP 5:

- Complete the six required steps to certify for Oscar Health:
 - Electronically sign the **Medicare Advantage producer agreement**.
 - Transmit your AHIP certification to Oscar Health.
 - Get appointed to sell in New York or Texas (where MA products will be available.)
 - Indicate your FMO affiliation.
 - Complete the **Oscar Broker Certification Training**.
 - All content from the course can be downloaded for future reference.
 - Complete the **Oscar Broker Certification Assessment**.
 - You have five attempts to achieve a passing score of 90% or higher.
